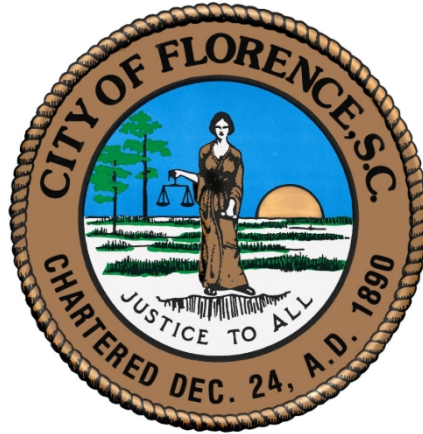
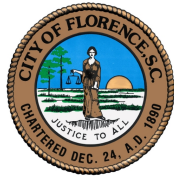

**Department:** Finance Department

**Issue Under Consideration:**

For City Council consideration is an ordinance to amend the FY 2026-27 City of Florence Budget.

**Current Status/Previous Action Taken:**

Ordinance was presented to City Council at a special meeting on June 15, 2026. Ordinance was amended to include an additional appropriation in the amount of \$164,000 for Pee Dee Regional Transportation Authority (PDRTA). The budget amendment passed first reading as amended.

**Points to Consider:**

The objective of the proposed ordinance is to amend the General Fund budget for FY 2026-27 to appropriate additional funding in the amount of \$264,000. \$100,000 to be appropriated for the Florence Regional Airport in accordance with the City's Community Programs. The funding will support marketing and community outreach efforts to increase public awareness of the airport's services and benefits, encourage greater passenger use, attract additional commercial air service, and strengthen the airport's role as a regional economic driver by supporting existing businesses and helping attract new investment. An additional \$164,000 to be appropriated for the Pee Dee Regional Transportation Authority (PDRTA) for the purpose of allowing increased weekday service hours until 9:00pm and increased weekend availability to better accommodate shift workers in the industrial, healthcare and service sectors.

**AN ORDINANCE TO AMEND THE BUDGET FOR THE CITY OF FLORENCE, SOUTH CAROLINA, FOR THE FISCAL YEAR BEGINNING JULY 1, 2026 AND ENDING JUNE 30, 2027**

**BE IT ORDAINED** by the City Council of the City of Florence, South Carolina, in a meeting duly assembled, that the budget for the City of Florence, South Carolina, for the fiscal year beginning July 1, 2026 and ending June 30, 2027, is hereby amended as follows:

**Section 1.** That the budgeted revenues of the General Fund are hereby amended by the following additional appropriations:

100375-435010      From Unappropriated Reserve is increased in the amount of \$264,000 from unassigned fund balance for appropriations not currently included in FY 2026-27 budget.

**Section 2.** That the budgeted expenditures of the General Fund are hereby amended by the following additional appropriations:

10049200-593170      Community Programs (Florence Regional Airport) is funded in the amount of \$100,000.

10049200-593020      Community Programs (Pee Dee Regional Transport Authority) is funded in the amount of \$164,000.

This Ordinance shall become effective immediately upon its approval and adoption of City Council of the City of Florence.
